In presenting this budget to the Commissioners' Court and to the taxpayers of Kent County, the following statistics are set out:

ASSESSED VALUATION------ACTUAL 2024 CERTIFIED VALUES----\$519,324,527

The above assessed valuation shows a **DECREASE** <u>from</u> that of the preceding year **2023** (\$560,377,022) of \$41,052,495 TAXABLE VALUE. 7.4% decrease. Total assessed valuation in Kent County for 2024 is based on approximately 100% of the true or market value of property assessed.

THE PROPOSED COUNTY WIDE TAX RATE TO FUND THE 2024/2025 budget is \$.0.83862 on each \$100.00 of assessed valuation.

THIS BUDGET REFLECTS A TAX REVENUE DECREASE of \$307,419 or 96.6% DECREASE FROM LAST YEAR. 2023 TAX LEVY was \$4,662.578; 2024 TAX LEVY is \$4,355,159

The total amount of County taxes levied from this budget, based on the certified assessed valuation of \$519,324,527 and TAX RATE OF \$.83862 is \$4.355,159. *Of this amount it is estimated that after discounts, \$\$4.268.055 TAX REVENUE will be collected within the current tax year and that approximately \$25,000.00 property taxes will be on Kent County delinquent tax roll on July 1, 2025.

DELINQUENT COUNTY TAXES due Kent County on August 22st, 2024 amounted to \$33,078.26 It is estimated that \$5,000.00 will be collected during the current tax year.
